Kindergartens

Hopetoun Kindergarten will be inspected under the National Quality Framework on 3 and 4 September 2013.

We have had to spend a great deal of time meeting the new Department of Education & Early Childhood Development data compliance by uploading to the new Kindergarten Information Management (KIM) system. Like most new systems that are meant to make our life easier, this one has been very time consuming and we have used the help desk many times to update our information into the system.

Aged and Disability

HACCPAC Mobile

Yarriambiack Shire Council has introduced the new HACCPAC mobile phone system to the first six Community Care Workers, which is taking over the old Daelibs system. Training went well, however a few glitches with the system. Michelle is working along side VADA from Melbourne to get this 100% sorted before we introduce the phone to the next six workers (Date to be confirmed). Workers have adapted to the phone very well and using it 100% correct which is great.

Michelle has been out in the field spending time with each worker within the households ensuring a smoother transition, which has been a success.

Volunteer Transport

Numbers up compared to last month. August is already looking to be busy, have quite a few early bookings. Volunteers are doing a great job.

Surveys

Have sent our survey to the volunteers to get their input and vision on how they feel as a Volunteer and to make sure they are being recognised by the Shire. To date, not a huge amount of negative feedback received. Overall results will be collated when surveys have all been returned.

Running late with Centre Based Meals surveys, but hoping to complete by mid August.

Improving Liveability for Older People (ILOP) Newsletter

A large amount of positive feedback has been received with the introduction of the ILOP newsletter, the number of responses to the Quiz has indicated that people are reading the newsletter.

Next ILOP Newsletter due early September.

Portsea Camp

Yarriambiack Shire Council has nominated preference dates for the Portsea Camp – 11 to 17 January 2014. We are now waiting for a reply and further information.

Two mothers have already contacted the Shire regarding the camp, enquiring as to when they can apply to send their children.

Environmental Health / Local Laws

Food premises inspections have been undertaken across the Shire, with no major non-compliances identified. One business in the south of the Shire did commence trading in July, however, closed only weeks after due to private unknown matters.

Onsite wastewater application numbers have remained steady for the month of July. One final permit has been issued with several preliminary inspections conducted and this includes the two new proposed CFA Sheds in Cannum and Speed.

A contractor engaged to assess the illegal clandestine drug laboratory has produced a report indicating that the remediation will be extensive and costly. Following appropriate legal advice, Council has fulfilled its statutory obligation by taking reasonable steps to ensure that no members of the public are at risk. Council is awaiting the results of an investigation by Victoria Police to determine the owner of the property who is responsible for remediation costs.

Work has commenced on Council's Public Health & Wellbeing Plan 2013-2017 with information support being provided by the Department of Health, Grampians Region. Information gathering is complete and draft goals for the plan are currently being considered / developed.

Council received one complaint in relation to the illegal dumping of wastewater. This matter has been investigated and the person responsible has been made aware that this practice is not acceptable.

A couple of dogs wandering and two cases of barking dogs reported this month. The Ranger is currently working with the dog owners to resolve.

To allow other tasks to be completed by Ranger, most cat cages were collected and therefore resulted in low numbers of cats being trapped this month.

There were several dogs / puppies surrendered to Council this month, all have been rehoused through pet rescue thanks to the amazing work they do.

Council's Domestic Animal Management Plan has been finished and supported at the last Council Forum. Plan is up for adoption this month.

The new Local Law No.5 is still under review with the last lot of changes being sent to the Solicitor's. This will allow us to take the next step in the process.

Brad Cox, Relief Ranger went to Adelaide and took part in the Dangerous Dog Handling Course. Brad provided positive feedback in regards to the course.

Work is continuing with the Building Department on derelict buildings across the Shire, with the latest one being the old second hand shop in Woolcock Street, Warracknabeal to be demolished later this week, due to it being unsafe and falling apart. This job is being done at the owner's expense after a notice was placed and an agreement was reached.

Celebrating Youth Grants

10.7 Infrastructure Services Report – Prepared by Bernie Naylor

Gardiner Street Drainage Pump

Works on the upgrade to the Gardiner Street, Warracknabeal storm water pumping station have now been completed.

As reported previously to Council following the major rain events and the issues we had in Gardiner Street regarding storm water drainage for that particular area, Council has engaged Rob Hudson from Midbrook Constructions to undertake the upgrade at the pump station.

The upgrade included installation of a second pump being a 225mm submersible pump. This pump has approximately six times the output of the existing pump and will become the primary pump with the existing pump being a backup in large rain events.

Contract C177/2013 Kerb and Channel Construction

As advised at the previous Council meeting the kerb and channel replacement program for 2013/2014 has been increased substantially.

Due to the increased amount of replacement work we have decided to tender out the replacement program.

Tenders for the abovementioned contract were advertised on 12 July, 2013 and closed on 2 August, 2013.

Council received eight tenders for this contract.

Evaluation of the contract will be presented to the Closed Session of Council.

Disposal of Asbestos

Recently small amounts of asbestos have been found in the skips at Council's Transfer Stations and also when removing or upgrading drainage pipes through the flood rectification works.

Council is prohibited from receiving asbestos at our transfer stations and must be taken to the Dooen Landfill.

We will be engaging a consultant to assist our transfer stations supervisors and some outdoor staff to identify asbestos and; advise on the correct procedures of removing and disposing of the material.

Mulching Program

As part of our "Free Green Waste" day in October as part of the Fire Awareness Week, we hope to run a trial at the Warracknabeal transfer station where residents will be able to dispose of their green waste, have it mulched and be able to take that mulch home for their gardens.

Funding through the Grampians Regional Waste Management Group will be available for this trial.

Classroom Environment Action Diary

Grampians Regional Waste Management Group's Education Officer, La Vergne Lehmann has been working with the Primary Schools in our region and has developed the "Classroom Environment Action Diary".

This diary will be over a period of six months and intends each month to address issues with the environment and suggests some tasks that the students can undertake to gain a better understanding of our environment.

Below, examples of some of the issues addressed:-

Contract C179/2013 Provision of Gravel Crushing Services

Each year Council rips and stockpiles approximately 120,000 tonnes of gravel for our Capital Works Program.

Council has been crushing this gravel now for a few years to assist in producing a better product when undertaking gravel re-sheets and rehabilitation works.

Council advertised the abovementioned contract on 2 August 2013 with tenders closing on Friday, 23 August 2013.

Contract C180/2013 – Expressions of Interest – Dry Hire of Tipping Trucks and Dog Trailers

Council in the carrying out of its Capital Works Program, on occasions will need to supplement its own plant by hiring additional Tipping Trucks with a Dog Trailer to assist in the completion of the Works Program.

The work to be carried out under this contract is the cartage of gravel and road aggregate.

Council advertised the abovementioned contract on 2 August 2013 with tenders closing on Friday, 23 August 2013.

DrumMuster Collections 2012-2013

Council has completed the reconciliation for our DrumMuster farm chemical container collection for 2012-2013.

Drums collected in this period were 31,335 it is interesting to note that for the previous 12 months Council collected 38,065 chemical drums.

The introduction of Enviro Drums and shuttles is starting to have an impact on the number of 20ltr drums used.

National Broadband Network Company (NBNC_o) has requested to lease a portion of land in the south east corner of the Rupanyup Recreation Reserve which is in Council ownership (*as per Appendix 1.1*).

The proposed lease is 20 years with option for extension. The proposed rental amount is \$7,000 with an annual increase of 2.5% per annum.

NBNC_o wish to construct, maintain and operate a telecommunications facility from the site, namely a 40m monopole to provide fixed wireless coverage via the National Broadband Network.

Section 190 of the Local Government Act 1989 provides a restriction on power to lease land. If the lease is for a period of more than 10 years, Council is required to advertise the proposed lease and invite submissions under Section 223 of the Local Government Act 1989.

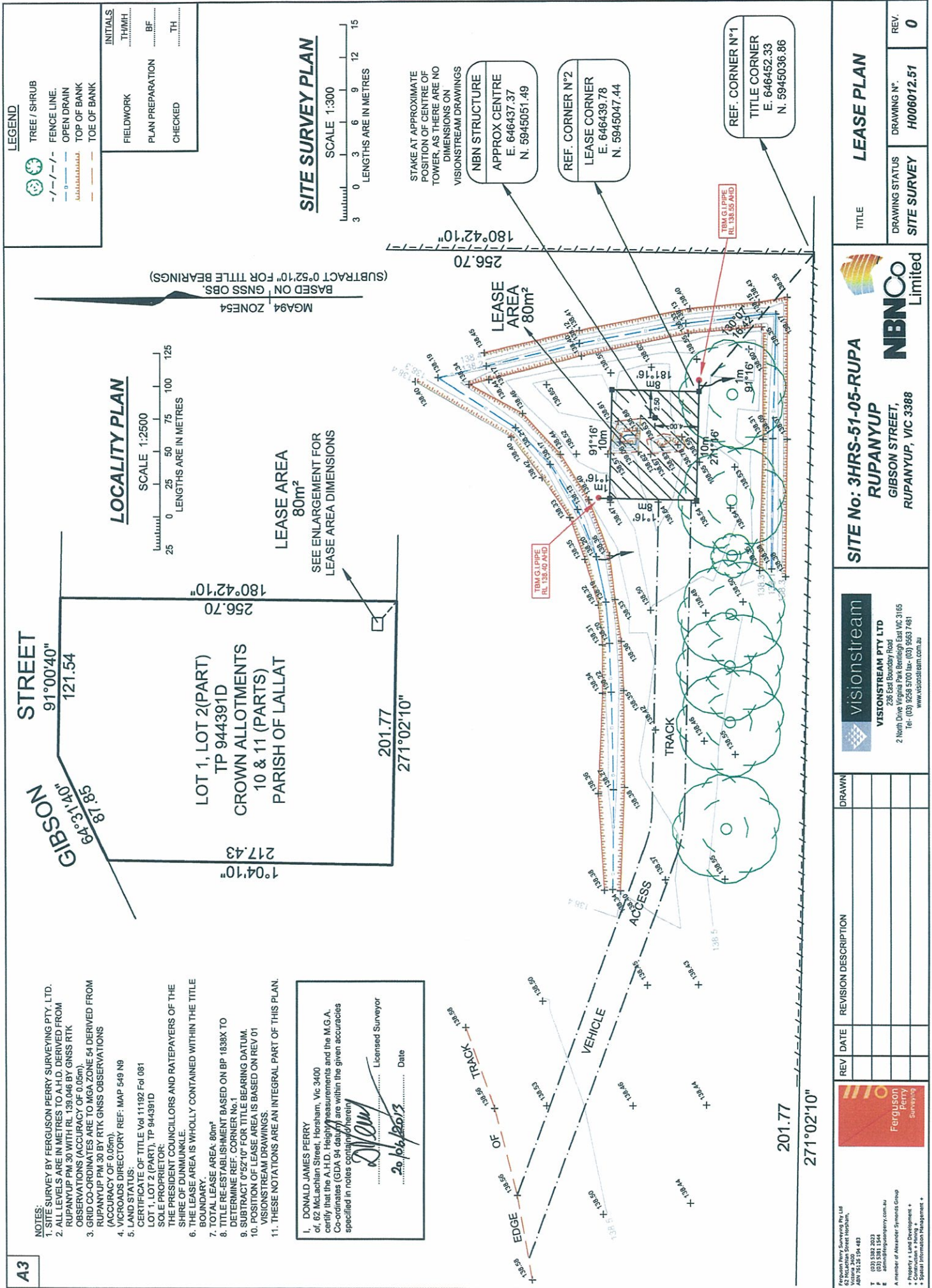
NBNC_o have not received a planning permit for their proposal as yet, however I believe Council should advertise its intent to lease.

PRIORITY 1: Remove second part of dot point; explore options to dedicate a resource to this function **through sharing costs with neighbouring Shires or through shared service arrangements.**

Leaving in first part is ok as it is not prescriptive and does not limit our options.

P.21

Providing twice yearly community awareness and education events / activities.

Costs for this beyond current funding could be changed to providing an annual event in line with children's week or education week.

Also further down the page a similar reference to twice yearly events is already occurring through the school system anyway.

P.22

Leave in first point about consulting with children and families when council is making decisions that affect them.

Point B is not a Shire responsibility. Other agencies do this.

Delete reference **to incentives and benefits packages** as we cannot fund this.

Also reference to **actively working with key stakeholders to ensure adequate provision of specialist services and assist groups to facilitate access to support groups needs** rewording.

Could be reworded to lobbying for adequate provision of services and support for groups to access needs.

Next point on **bi monthly parenting information sessions** is just not achievable. MCH do this individually and we put out a newsletter each term monthly is not achievable.

Next is the reference to twice yearly events that needs rewording to an annual event.

Creating a parent hub can be reworded to explore options to provide more services in our early years facilities.
